## Community Boards: Our Historical & Groundbreaking Track Record

Now celebrating its 50th year, Community Boards has been helping San Franciscans navigate conflict since 1976. We equip people with practical, accessible tools to resolve disputes, strengthen relationships, and build safer, more connected communities—without courts, cops, or lawyers.

Our work spans mediation, conflict coaching, facilitation, restorative community conferencing, circles, and referrals, addressing everything from neighbor and family disputes to community-wide and workplace issues.

### What sets us apart:

- Pioneered a **collaborative panel mediation model**, bringing up to three trained mediators together to create a safe, confidential space for resolution.
- Built one of the city's most **meaningful volunteer pathways**, offering hands-on, skill-building opportunities for community members to make real impact.
- Helped more than **60,000 San Francisco residents** resolve conflicts peacefully and trained over **26,000 people** in conflict resolution and mediation.
- Provide services **citywide** in English, Spanish, Mandarin, and Cantonese.
- Train volunteer adjudicators in **restorative justice** for the SF District Attorney's Neighborhood Courts Program.
- Support an active network of **450+ volunteer mediators, coaches, facilitators, restorative practitioners, and trainers**.
- Partner across the city with public agencies and nonprofits including SFPD, SF311, SFUSD, the SF Rent Board, the Planning Commission, housing and tenant rights organizations, and more.
- Launched the **Conflict Manager Program** in 1982—one of the nation's first peer mediation models in schools.
